

Live Better Academy 'Credit Score Course' Competition Rules

Prizes

- 10 X R1 000 monthly cash prizes during 17 February 2023 – 28 February 2023

Competition period

The competition will run from 17 February 2023 and close on 28 February 2023.

How to enter

- Create an account on the [Live Better Academy](#), or log in to your existing account
- Complete the **Building a Credit Score** course on the Live Better Academy with a knowledge level of 3 or above during the competition period ("valid entry") to be entered into a lucky draw to win one of the R1 000 prizes

Competition terms and conditions

2. The competition will run from 17 February 2023 and close on 28 February 2023

Winners will be contacted telephonically or by email before the 15th of the following month and in the event that a winner cannot be reached by telephone or email after 3 (three) attempts within 4 (four) weeks from the time of the draw, the promoter reserves the right to draw another winner and the prize will be forfeited by such winner
9. Prizes are not transferable or negotiable
10. The cash prizes will be deposited directly into a Capitec savings account opened and maintained in the name of the winner within 2 (two) weeks of the winner being successfully contacted
